**ORDINANCE AMENDING SECTION 70-10 OF THE MUNICIPAL
CODE OF THE VILLAGE OF STEGER**

WHEREAS, sec 70-10 Collection Program provides for garbage and refuse program for the Village of Steger; and,

WHEREAS the Ordinance needs to be amended to reflect the program provided for in the Village’s contractual arrangement with Allied Waste Transportation, Inc.; and,

WHEREAS, it is in the best interests of the residents of Steger that this amendment is made.

NOW, THEREFORE, BE IT ORDAINED, by the President and Board of Trustees of the Village of Steger, counties of Cook and Will and State of Illinois, that Sec 70-10 Collection Program is repealed and in lieu thereof the following provisions are adopted.

Sec 70-10 Collection Program

- a. The Village having advertised for waste collection proposals to increase services and lower costs hereby adopts the low bidder, Allied Waste Transportation, Inc. as the waste collector and disposal company for all single family and multifamily dwellings of 3 or fewer residential units

- b. That all covered residential units are required to have garbage and refuse service through Allied Waste Transportation, Inc.
- c. That Allied Waste Transportation, Inc. shall bill its monthly charge directly to each residential unit on a quarterly basis.
- d. That the persons in whose names the Village water bill is issued and/or the owner of the dwelling is liable for the payments of the garbage and refuse collection bills.
- e. Any person(s) who knowingly and willfully refuses to pay for the garbage and refuse service within 60 days of receiving the quarterly statement shall be subject to a fine of not less than \$50.00 nor more than \$750.00.
- f. Any person who willfully damages a collection container provided by Allied Waste Transportation, Inc. or removes same from the residential unit for which it is intended shall be subject to a fine of not less than \$50.00 nor more than \$750.00.
- g. The Village of Steger shall not issue occupancy permits to covered residential units which are not current in the payment of its garbage and refuse service.
- h. That since the collection program is a program of the Village of Steger instrumented by Allied Waste Transportation, Inc. pursuant to contract, the Village grants unto the company the right to file liens for the services it has provide against the real estate of the dwelling unit.

This Ordinance shall be in full force and effect 30 days after its passage, approval and publication as made and provided by law.

If any portion this ordinance is held to be unconstitutional, it shall not affect the validity of the remaining portions
